In consideration of being permitted to participate in volunteer activities organized by Nature Collective, a California non-profit corporation, the undersigned, for himself/herself and on behalf of the minor children listed below, and any of my/their respective personal representatives, heirs, executors, next of kin, successors and assigns, hereby agrees to the following:

**VOLUNTEER RESPONSIBILITIES.** • Always act in a professional and respectful manner. • Be safety conscious at all times. • Be courteous to all persons with whom you come in contact. • Always check in and out with your designated supervisor. • The use of alcohol and controlled substances is absolutely prohibited.

I have read these volunteer responsibilities and agree to adhere to them, and ensure that my minor children adhere to them, at all times while participating in volunteer activities organized by Nature Collective. I also agree to abide by, and ensure that my minor children will abide by, all of Nature Collective's rules and requirements for any volunteer activities that they participate in. I understand that my failure, or the failure of my minor children, to abide by the foregoing may lead to my termination from the volunteer program.

**SCOPE OF VOLUNTEER ACTIVITIES AND ASSIGNMENT.** On behalf of myself and my minor children, I understand that we are agreeing to act as volunteers and that our volunteer activities may take place at one or more locations that are owned, operated, managed, maintained and/or used by Nature Collective and that our volunteer activities may include, but are not limited to, the following; walking, hiking, Page | 1

operating, guiding, and navigating upon and through marked and unmarked trails, roads open to vehicular traffic, brush and foliage, hills, stairs, bridges, rocks and rock formations, hillsides, gates, fences, and/or other adverse conditions that may be present at the locations where the volunteer activities take place. On behalf of myself and my minor children, I also understand and agree that we may encounter, and come into contact with, animals, insects, and other wildlife during our time as volunteers for Nature Collective. Our activities as volunteers may also include consuming food and liquids available or provided, and spending extended periods of time outdoors in the sun and/or during inclement weather.

**EQUIPMENT.** On behalf of myself and my minor children, I understand that in order to fulfill duties as a volunteer for Nature Collective, we may be required to provide my own equipment, including but not limited to the following; footwear appropriate for the given activities, sunscreen, insect repellant, hats, sunglasses, bicycles, canes, helmets, and other safety equipment ("the Equipment"). On behalf of myself and my minor children, I agree that we will be responsible for providing for any such Equipment and we are responsible for the use of such Equipment. On behalf of myself and my minor children, I agree that Nature Collective has no responsibility to provide any Equipment and has no responsibility or liability for our failure to use, or our use of, the Equipment.

**MEDICAL TREATMENT.** On behalf of myself and my minor children, I agree to release and forever discharge Nature Collective from any claim whatsoever which arises or may hereafter arise on account of any first aid, treatment, or service rendered to me and/or any of my minor children in connection with the Volunteer Activities (as hereinafter defined).

**ASSUMPTION OF RISK**. On behalf of myself and my minor children, I assume the responsibility of mental and physical fitness of myself and my minor children to participate in the scope and assignment described above and any other volunteer activity that I and they may participate in (the "Volunteer Activities"). On behalf of myself and my minor children, I also assume the responsibility for any damage to our personal property and Equipment during any of my and my minor children's Volunteer Activities.

RELEASE OF LIABILITY. ON BEHALF OF MYSELF AND MY MINOR CHILDREN, I ACKNOWLEDGE THAT PARTICIPATION IN THE VOLUNTEER ACTIVITIES INVOLVES RISK, BOTH KNOWN AND UNKNOWN, INCLUDING BUT NOT LIMITED TO PHYSICAL INJURY (EVEN DEATH), EMOTIONAL INJURY, DAMAGE TO PERSONAL PROPERTY AND EQUIPMENT, AND OTHER DAMAGE. ON BEHALF OF MYSELF AND MY MINOR CHILDREN, I ACKNOWLEDGE THAT WE ARE VOLUNTARILY ENGAGING IN THE VOLUNTEER ACTIVITIES WITH KNOWLEDGE OF THE RISKS OF INJURY (EVEN DEATH), DAMAGE TO PROPERTY AND EQUIPMENT, AND OTHER DAMAGE, AND ON BEHALF OF MYSELF AND MY MINOR CHILDREN, I ASSUME ANY AND ALL RISK OF INJURY TO MYSELF AND MY MINOR CHILDREN (EVEN DEATH), DAMAGE TO PERSONAL PROPERTY AND EQUIPMENT, AND OTHER DAMAGE THAT MAY RESULT FROM PARTICIPATION IN THE VOLUNTEER ACTIVITIES. **INSURANCE.** On behalf of myself and my minor children, I understand that we are not employees of Nature Collective for the purposes of Workers' Compensation, or for any other purpose, but that Nature Collective may choose to maintain volunteer accident insurance that may provide some coverage in excess of any other medical insurance we may have, although any such volunteer accident insurance is not guaranteed. On behalf of myself and my minor children, I agree to comply with the Nature Collective's policy on reporting any injuries or damages we may incur while participating in Volunteer Activities and agree that we will report the occurrence of any such injuries or damages immediately.

On behalf of myself and my minor children, I, understand that, except as otherwise agreed to by Nature Collective in writing, The Nature Collective is under no obligation to provide, carry, or maintain health, medical, travel, disability, or other insurance coverage for us and that we are expected and encouraged to obtain our own health, medical, disability, or other insurance coverage.

**PHOTO/VIDEO RELEASE.** In connection with our participating in the Volunteer Activities, on behalf of myself and my minor children, I hereby give permission to Nature Collective to use our photograph(s) and video/audio recording for official Nature Collective printed publications, outreach events, website, and/or social media platforms without further consideration. On behalf of myself and my minor children, I acknowledge Nature Collective's right to crop or edit the photograph or video/audio recording at its discretion. On behalf of myself and my minor children, I acknowledge that Nature Collective may choose not to use our photo or video/audio recording at this time, but may do so at its own discretion at a later date. On behalf of myself and my minor children, I also understand that once our image or video/audio is posted on Nature Collective website, it can be downloaded by any computer user.

RELEASE OF LIABILITY. ON BEHALF OF MYSELF AND MY MINOR CHILDREN, I HEREBY RELEASE, WAIVE, DISCHARGE AND COVENANT NOT TO SUE THE LAND CONSERVANCY, ITS OFFICERS, DIRECTORS, TRUSTEES, COMMITTEE MEMBERS, EMPLOYEES, VOLUNTEERS, REPRESENTATIVES, AGENTS, SUCCESSORS AND ASSIGNS (COLLECTIVELY, THE "RELEASEES") FROM ALL LIABILITY TO ME AND MY MINOR CHILDREN AND OUR PERSONAL REPRESENTATIVES, HEIRS, NEXT OF KIN, SUCCESSORS AND ASSIGNS FOR ANY AND ALL PRESENT OR FUTURE LOSSES, CLAIMS, DEMANDS, DAMAGES OR LIABILITES OF ANY NATURE ARISING FROM OR RELATING TO PARTICIPATION IN THE VOLUNTEER ACTIVITIES BY ME AND MY MINOR CHILDREN, REGARDLESS OF WHETHER CAUSED BY THE CARELESSNESS, NEGLIGENCE, GROSS NEGLIGENCE, OR WILLFUL ACTS OF RELEASEES.

**INDEMNIFICATION.** On behalf of myself and my minor children, I agree to indemnify, defend and hold harmless the Releasees from any and all losses, liabilities, damages, expenses (including without limitation attorney's fees and costs), claims, actions, or proceedings of any kind arising from or relating to Page | 3

participation in the Volunteer Activities by me or my minor children, regardless of whether caused by the carelessness, negligence, gross negligence, or willful acts of Releasees.

**APPLICABLE LAW.** On behalf of myself and my minor children, I understand that this document is intended to be as broad and inclusive as permitted by the laws of the State of California and agree that if any portion of this Agreement is invalid, the remainder will continue in full legal force and effect. On behalf of myself and my minor children, I also agree that the venue for any dispute arising from the Volunteer Activities will be in the San Diego County Superior Court in the County of San Diego, CA.

By signing below, I am agreeing to all of the terms stated above on my behalf and on behalf of my minor children. I represent and warrant that I am the parent or legal guardian of the minor children listed below and that I have the authority to enter into this agreement on their behalf.

I HAVE FULLY INFORMED MYSELF OF THE CONTENTS OF THIS VOLUNTEER LIABILITY WAIVER BY READING IT BEFORE I SIGNED IT. I REALIZE THAT BY SIGNING THIS DOCUMENT I AM GIVING UP LEGAL RIGHTS TO WHICH MY MINOR CHILDREN AND I MAY BE ENTITLED AND AM ELIMINATING THE LIABILITY OF ANY AND ALL OF THE RELEASEES.
